This form must be submitted to the Arabian Horse Society of Australia Ltd where a hair sample is to be stored for future DNA analysis

1. I am the authorised agent for the owner/breeder (cross out which does not apply) of the Arabian/Arabian Derivative stallion/colt/mare/filly/gelding (cross out which does not apply) named

3. I acknowledge that any DNA analysis required by the AHSA Ltd is to be carried out by the Australian Equine Genetics Research Centre or any other such laboratory as the AHSA may from time to time prescribe at my expense.
4. I acknowledge that it is entirely my responsibility to provide such DNA analysis as the AHSA Ltd shall require.
5. I am aware that I may deposit with the Australian Equine Genetics Research Centre or any other such laboratory as the AHSA may from time to time prescribe a sample of genetic material from (Insert full registered name of horse for which sample is to be stored) to be held by that laboratory for DNA analysis when requested by me. I also expressly authorise the AHSA Ltd to request any such DNA analysis for its own use for any genetic sample held on my behalf without further consent or authority from me. I further acknowledge the deposit of such genetic material with that laboratory is entirely at my own risk and I accept that in the event such material is lost or destroyed or is unsuitable for DNA analysis that the AHSA Ltd may not register any progeny of (Insert full registered name of horse for which sample is to be stored) for export outside Australia.

CONSENT TO STORE AND DISCLOSE RESULTS FROM SAMPLE

The owner/breeder ("you") of the Arabian/Arabian derivative Horse ("the Horse") whose details appear below:

- 1. Makes application for the AEGRC ("us") to perform DNA testing on the enclosed sample of genetic material ("the sample") taken from the horse in the manner and to a standard specified by the Arabian Society of Australia ("AHSA").
2. Provides consent to this sample being retained by us following testing and dealt with in the following ways:
a. Retained in storage by the us, indefinitely, without any assurance or guarantee as to the future availability or condition of the sample stored;
b. Forwarded to the AHSA upon request by the AHSA to us.
c. Used to satisfy any further enquiry made by the AHSA to us and of which you may be unaware.
3. In providing this consent form, you acknowledge:
a. An opportunity to read and consider the requirements of the AHSA located at www.ahsa.asn.au and the implications of these requirements for provision to the AHSA of results of DNA testing if the Horse and any progeny born after 1 August 2004 are to be eligible for export from Australia; and
b. Storage of the sample is entirely at your own risk and that no liability will attach to the AEGRC if the sample is lost or destroyed or deteriorates to a level where it is unable to be used for any of the purposes for which consent is provided.
